1.0 INTRODUCTION

- iv) Evidence financial capability to execute the project by submission of Reference letter from a reputable commercial bank indicating willingness to provide credit facility for the execution of the project when needed;
- v) Evidence of firm's registration/current practicing License with relevant professional body;
- vi) For joint venture/partnership, memorandum of understanding (MOU) should be provided;
- vii) Sworn affidavit disclosing:
 - a) That the firm is not in receivership, insolvency or bankruptcy;
 - b) That the firm does not have any Director who has been convicted by any court in Nigeria and any other country for criminal offences in relation to fraud or financial impropriety ;
 - c) That no officer of Adeyemi College of Education, Ondo is a former or present Director or partner of the firm;
 - d) That all information presented in the documents are true and correct in all particulars.
